



VOLUNTARY GROUP FOR THE FOLLOW UP OF THE INTER-AMERICAN DEMOCRATIC CHARTER

PROPOSED GUIDELINES

INTRODUCTION	
	<p>In 2001, the OAS General Assembly approved the Inter-American Democratic Charter, in which the Member States recognized that "The people of America have the right to democracy and their governments have the obligation to promote and defend it," and that "democracy is essential for the social, political and economic development of the people of the Americas". This Charter also recognizes that elements of representative democracy include, among others, "respect for human rights and fundamental freedoms; access to power and its exercise subject to the rule of law; the holding of periodic, free elections, fair and based on universal and secret suffrage as an expression of the sovereignty of the people; the plural regime of political parties and organizations; and the separation and independence of public powers", and that "democracy and economic and social development are interdependent and mutually reinforcing. Likewise, Member States agreed to periodically review the actions adopted and executed by the Organization aimed at promoting dialogue, cooperation for comprehensive development and the fight against poverty in the Hemisphere and take appropriate measures to promote these objectives. The OAS can only thrive as a beacon for democratic practice if its constituent members actively participate and collaborate in initiatives that transcend borders and unite them in the shared pursuit of inclusive, accountable, and responsive democratic institutions. The Voluntary Group offers an opportunity to revitalize the region's commitment to the Democratic Charter, based on mutual understanding, respect and active cooperation.</p>
MANDATE	
	<p>The General Assembly of the OAS, in its 53rd regular session of the General Assembly, issued a mandate contained in resolution Strengthening Democracy AG/RES. 3004 (VI. Follow-up of the Inter-American Democratic Conference), in which it encourages "the creation of an open-participation Voluntary Group of Member States to foster, with the support of the Secretariat for Strengthening Democracy, dialogue, horizontal cooperation and the sharing of best practices among its members, and to identify opportunities within the principles of the OAS Charter and the Inter-American Democratic Charter to strengthen their democracies."</p> <p>This mandate responds to the interest of Member States in strengthening dialogue and cooperation on democracy, considering the new challenges it faces, some of which were described in the Joint Statement "Follow-up of the Inter-American Democratic Charter, on the occasion of the International Day of Democracy", issued by 26 Member States on September 20, 2023, and in which it was reaffirmed the interest in better implementing the Charter based on mutual respect, dialogue and cooperation, the principle of non-intervention, and the exchange of experiences and best practices; improve the quality of our democracies; and strengthen the continuous and creative work to consolidate democracy, as well as a permanent effort to prevent and anticipate the very causes of the problems that affect the democratic system of government.</p>

OBJECTIVE OF THE VOLUNTARY GROUP FOR THE FOLLOW-UP OF THE INTER-AMERICAN DEMOCRATIC CHARTER

Foster dialogue, promote horizontal cooperation and the exchange of best practices among the members of the Voluntary Group of the Follow-up of the Inter-American Democratic Charter to strengthen their democracies in accordance with the principles of the OAS Charter and the Inter-American Democratic Charter.

FUNCTIONING

Authorities:
The Voluntary Group will have a president and a vice-president, who will be elected from among the representatives of the Member States that have expressed their willingness to participate in the group.

Duration:
The president and vice president will serve for a period of six months, which may be renewable for a single additional period of six months.

Frequency of meetings:
Group meetings will be held once a month or every two months.

Meeting format:
Group meetings will be held in a hybrid manner (in person and via Kudo). Only members of the delegations of the Member States, including representatives from capitals when necessary, will be able to participate in the virtual meetings. The meetings are not open to the public, only to Member States.

Technical and logistical support:
The Secretariat for Strengthening Democracy–SSD–will support the Voluntary Group in the functions entrusted to it, in accordance with the mandate of the General Assembly. Among these functions are:

- Convene the meetings of the Voluntary Group via Verbal Note.
- Coordinate necessary services with the Department of Conference.
- Prepare documents as requested, including meeting agendas.
- The languages in which the group will work are English and Spanish.
- Prior to meetings, consolidate information on the programs carried out by the OAS on the topics to be addressed at meetings, in order to avoid duplication of efforts.

Financing of meetings and activities promoted by the group:
Services provided at the meetings (coffee, water) and translation of documents will depend on the availability of financial resources.

If the Member States so decide, the SSD may request financial support from permanent missions and observer missions to the OAS.

DEBATES

The debates will be aimed at seeking to identify opportunities for horizontal cooperation and exchange of good practices among the members of the group, as well as possible lines of action that seek to take advantage of the instruments already existing in the inter-American system for the promotion and strengthening of democracy. None of the documents produced by the group will be binding.

If the group deems it pertinent, external experts and civil society organizations may be invited to participate in the debates. Said participation will be subject to prior agreement between the members of the group, to ensure, as far as possible, equitable geographical representation, reflecting the democracies and cultural diversity of the members of the Voluntary Group.

The group may submit to the Chairman of the Permanent Council information on the development of its activities, so that they could eventually be taken into account as inputs in the preparatory processes of the General Assembly of the OAS and other political bodies.

The data and documents used in group discussions must be impartial and provided voluntarily by the members of the group.

The Presidency of the Voluntary Group, in accordance with its members, is the only body authorized to make public statements or pronouncements on social networks in name of the group, about its work and activities. However, this does not prevent representatives of Member States from communicating about their participation in the meetings.

DURATION, PRIORITIZATION AND ACCOUNTABILITY	
	<p>This work plan shall be valid for twenty-four (24) months. Within this framework, every six months the Group will review its work and prioritize the activities or topics to be addressed in the following six-month period, in accordance with available resources, and make possible adjustments to the Work Plan when appropriate.</p>
